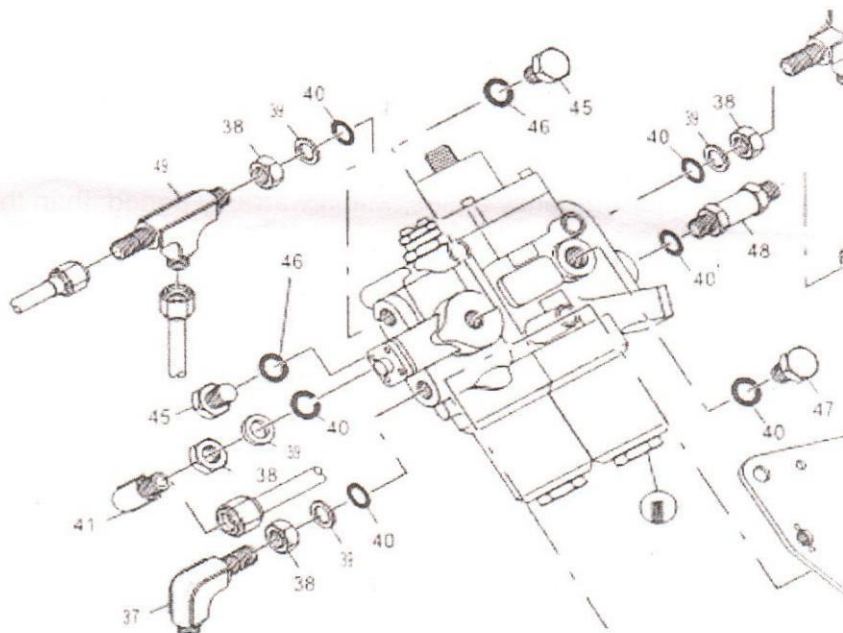



Figure: Valve, Solenoid

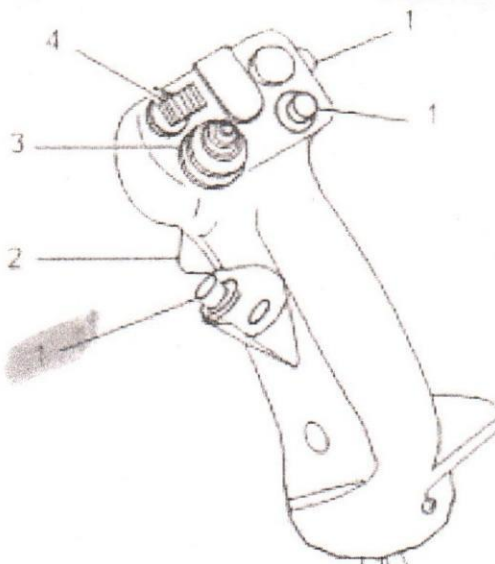


Figure: Push, Button
