- 21. <u>Warranty</u>, Warranty for trouble free operation is to be given by the principal/manufacture for a period at least 1(One) year from the date of acceptance by the buyer. During the warranty period, if the item remains non-operational for any action pending by the supplier, the warranty period will be extended for the same period. The warranty covers all parts and labor (including service engineer's cost) throughout the warranty period.
- 22. <u>Guarantee</u>. The manufacturer shall guarantee to supply necessary spare parts for at least 01 (One) year with reasonable price.

23. Shipment.

- a. The supplier will arrange shipment of all items by sea port/ air port to Chattagram/ Dhaka Bangladesh.
- b. All items are to be delivered in sea-worthy packing to ensure safe transportation by sea/ air.
- c. All packages are to have packing notes showing their contents in details and all packages shall be marked with the name and address of the consignee and gross weight.
