

**TECHNICAL SPECIFICATION OF ROLLER DOOR INSTALLATION FOR BN MPA
(NAVAL AVIATION)**

1. **Item's Identification.**
 - a. Applicable Aircraft Model : Dornier 228-212NG
 - b. Name of the Item : Roller Door Installation
 - c. Part No : AA262250C00C
 - d. Name of the System : Door Installation
 - e. Manual/ Parts Catalogue Reference : Roller Door Installation Illustrated Parts Catalog (AIPC) Chapter 52-10-00, 06A.

2. **Purpose.** Passengers board or exit from the plane through these doors.

3. **Quantity.** 01 (One) in no.

4. **Manufacturer Details.**
 - a. Country of Origin : Germany or EU
 - b. Manufacturer Address : General Atomics Aero Tec Systems GmbH, Germany
 - c. Year of Manufacture : 2010 or Later.

5. **Source of Supply.** To be mentioned.

6. **Scope of Supply.** Serviceable/ Refurbished item is to be supplied fulfilling all the criteria of technical specification.

7. **Test, Trial and Acceptance.** Final acceptance of the item will be given after satisfactory test and trial by MPA Fit Line.

8. **Warranty.**
 - a. Warranty is to be given for trouble free operation for a period of minimum 12 months from the date of acceptance by MPA Fit Line.
 - b. If any defect/ discrepancies arises within warranty period, then the respective item is to be replaced in the condition of free of cost including freight within 02 months from the date of notification of the same to the supplier.
 - c. Warranty period will be extended for the same amount of time in which the item will remain non-operational.

9. **Bidder's and Principal's Identification and Qualification.**
 - a. **Bidder Address: (Full address, Contact no and E-mail address).** To be mentioned.
 - b. **Bidder's Qualification.** Bidder is to be authorized by OEM (Equipment/ Aircraft) or OEM (Equipment/ Aircraft) authorized principal.
 - c. **Principal's Address (Contact no and Email address).** To be mentioned.
 - d. **Principal's Qualification.** OEM (Equipment/ Aircraft)/ or OEM (Equipment/ Aircraft) authorized principal can submit quotation.

10. **Certification.**
 - a. **During Quotation.**
 - i. The bidder is to provide an authenticity Certificate from OEM (Equipment/ Aircraft) or OEM (Equipment) authorized principal with the quotation.
 - ii. If the item is provided from the OEM (Equipment/ Aircraft) authorized principal then the bidder is to provide the authenticity certificate from OEM (Equipment/ Aircraft) for the principal with the quotation.
 - iii. The bidder is to provide a certificate of Warranty/ Guarantee with the offer quotation.

b. During Delivery of Item.

- i. The bidder is to provide Authorized Released Certificate (ARC) with the item.
- ii. Repair/ Overhauling certificate is to be provided with the item.

11. Handling of Item.

- a. Delivery Point : NSD, Chattogram.
- b. Country/ Port of Shipment : To be mentioned.
- c. Shipment (Air/Sea) : To be mentioned.
- d. Delivery Time : 30 days from the date of purchase order issue.

- a. Price : To be mentioned.
- b. Applicable Tax/ Vat : Local Tax/ VAT will be borne by supplier.
- c. Terms of payment : After satisfactory test/ trial and acceptance by BN, 100% payment will be made in local currency as per the existing rule.

13. Bidding Conditions.

- a. Offer Validity : The offer should remain valid up to 180 days.
- b. Compliance Statement : A compliance statement fulfilling all the requirement of the tender is to be submitted for evaluation of the quotation. An incomplete compliance statement may attribute to cancellation of the offer. If any clause of this specification does not commensurate with offer, the deviation has to be clearly mentioned.
