

Necessary proof/ certificates in this regard are to be submitted with the offer. If the Bidder is a 'Reseller', the parent Dealer shall provide a certificate, clearly stating that they will remain 'Solely Responsible' to BN for installation and future maintenance-support of their products as per relevant clauses of this tender (in case the Bidder fails to meet this obligation).
