- 15. <u>Scope of Supply</u>: 01 (One) complete set of BD BACTEC FX40 Automated Blood Culture System will have to be supplied with all attachments, accessories etc and complete in all respect for immediate operation.
- Technical features /facilities:

- 21. <u>After Sales Service</u>: The supplier should have requisite after sales service facilities at home to render necessary services as and when required by BN. Necessary agreement will be signed if required.



22. <u>Test, Trial and Acceptance</u>: The supplier will carry out installation, test and trial of the supplied machine at his own cost. The acceptance of the supplied items will be carried out by BNS UPASHAM where the supplier's representative will be present. After the satisfactory test/trial, with certificate the acceptance certificate will be given by the Acceptance Committee of NSD Khulna.

23. Warranty/Guarantee:

- a. The supplier must ensure that all items are new and unused. The supplier must provide warranty at least for 02 (two) years from the date of acceptance of the item(s) after satisfactory inspection, test, trial etc as applicable. If any defect/discrepancy of any item arise within the period of warranty, the specific period from the date of notification of the defect/ discrepancy to the supplier upto the date of rectification of defect/resolve of discrepancy will have to be deducted from the warranty period for that particular item(s).
- b. In warranty period the supplier will provide all accessories, maintenance and repair services. If any defect/discrepancy arises, within warranty period, then the respective item(s) is/are to be replaced free of cost including freight within 03 (three) months from the date of notification of the same to the supplier. In this regard, the supplier must furnish an undertaking with the offer by stating, "I do hereby assure that we take the liability to replace all spare parts/item(s) free of cost including freight within three months from the date of notification about the defect/discrepancy of the spare parts/item(s) by the buyer, if it occurs within the period of warranty".
- c. The service should be provided within 7 days hours from the date of complaints lodged.
- d. The equipment should run 98% days of a year in warranty period. Otherwise a compensation of a fixed amount service may be deducted from performance security.
- e. After expiry period the supplier should be responsible for providing Supply of spare parts supply, update software and defect detection, Repair and maintenance of the equipment's as far contract agreement.
- f. Warranty period will be counted from the date of acceptance committee of NSD Khulna.
- g. In warranty period the supplier will provide all maintenance & repair services free of cost.
- h. Breach time will not be considered in warranty period. The period for repair of replacement shall be: within 7 days. Otherwise breach time (if not repaired within 24 hours) will be added with warranty period.
