

13. **Power Supply.** The system should run with 180-250V AC, 50Hz, 1Ph and 12/ 24 Volt DC Power Supply.

14. **Standard.** LED TV, supplied under the scope of the supply are to be designed, constructed/ manufactured and tested up to the requirement of OEM standard or other appropriate MII standard and shall comply other referenced standard.

5. **Documents:**

a. 01 (One) set of following documents/ manuals in English are to be provided with the each system at the time of delivery:

- (1) Operating Manual.
- (2) Technical Manual with Circuit Diagram.
- (3) Installation Manual with Installation Drawing.

b. **Brochure/ Booklet** 01(One) set of Brochure/ booklet in English incorporating technical details with necessary drawing/ diagram of the offered system including general out line must be provided with the offer for evaluation/ assessment.

6. **Test, Trial and Acceptance.** The system is to be handed over to BN on successful test/ trial of the system on site by the supplier. Final acceptance will be given by BN (CINS)/ ACINS after satisfactory performance test of the system. It is to be noted that Test/ Trail is to be completed within 03 months from the date of receipt of the equipment at NSSD Dhaka. If any discrepancy is noticed on receipt of equipment at NSSD Dhaka, it is also to be solved within this period.

7. **Warranty.**

a. Minimum 12 Months warranty for trouble free operation is to be provided by the supplier/ manufacturer for the item from the date of acceptance by the buyer. If any component of the supplied items becomes defective during the warranty period, the warranty shall be extended automatically (for relevant component) for the period of the subject component remains defective.


b. For warranty repair/ replacement, the supplier will collect the defective item form NSSD Dhaka/ NSD, Chittagong and re-supply the same to collecting place after warranty repair or for replacement within 90 (ninety) days from the date of defect at no cost to the purchaser.

8. **Guarantee.** The supplier is to give guarantee of continued supply of spares for at least 10 years at a reasonable price.

9. **Technical Support.** Technical support is to be provided to solve any maintenance and operational problem arising with the item for a considerable period (To be mentioned). Assurance by the bidder stating agreement in this respect is to be submitted with the offer.

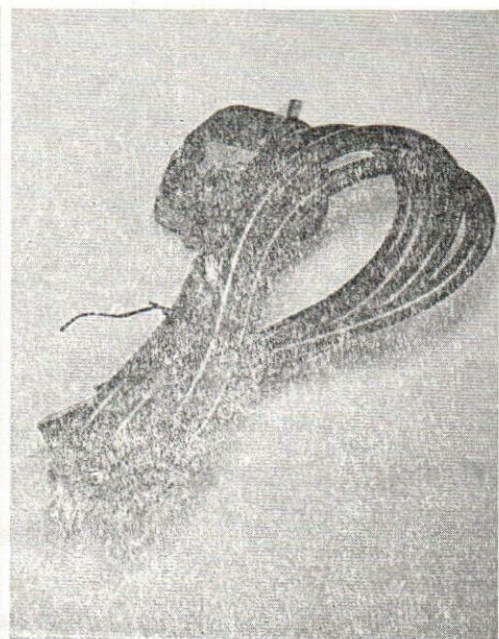
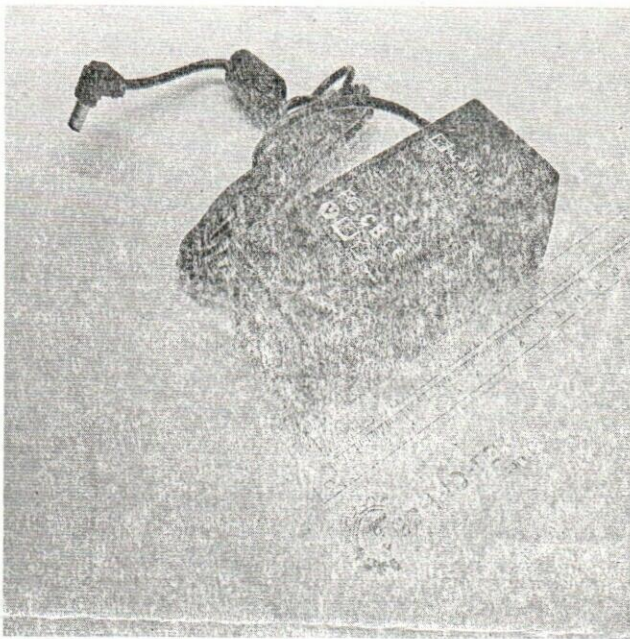
