- 9. Qualification of Bidder. Only the genuine manufacturers or their authorized dealer can submit quotation through their authorized agent in Bangladesh. In case of dealer, manufacturer's certificate of authorization has to be submitted with the offer.



- 12. Fabric. Fabric will be supplied by Bangladesh Navy. Bandolier of CSMG shall be made of washable cloth. It is to be robust composition of Polyester  $53\% \pm 3\%$  & Cotton  $50\% \pm 3\%$  fabric. A certificate from original manufacturer is to be submitted with offer stating that standard (BN Supplied) fabric, velcro and other accessories are used in the offered Bandolier.
- 13. <u>Dye Fastness to Sunlight, Color Fastness to Wash, Light, Rub, Perspiration, Sea Water Test and Pilling (Martindale) Test</u>. The fabric provided for the work is tested for following specification/criteria:
  - a. Dye Fastness to Sunlight. (Method: ISO/DIS 16373 1) Vat disperse
  - b. <u>Color Fastness to Wash</u>: (Method: BS ISO 105 C10 E(5)-2006, single test, 4 hours mechanical wash at 95° in 5g soap detergent, 2g sodium carbonate with 10 steel ball).

- 14. <u>Shelf Life</u>. Minimum Operational Shelf Life of 05 years. Shelf life certificate from manufacturer is to be provided with the offer.
- 15. <u>Manufacturer's Certificate</u>. Certificate from the manufacturer is to be provided with the offer indicating the year of manufacture and confirming that the offered item will meet the purpose and technical characteristics mentioned in Para 2, 10 and 11.
- 16. <u>Sample.</u> Two in no sample of Bandolier CSMG with carry Bag is to be supplied by the bidder along with the offer. **Offer without sample will not be accepted**.
- 17. <u>Packing Details</u>. Each Bandolier CSMG is to be supplied in standard Rexin carry bag and 50 in no Bandolier is to be supplied in a standard paper carton. Each package is to be marked as follows:



# 18. Warranty.

- a. Minimum 12 (twelve) months warranty from the date of acceptance by the buyer for trouble free use is to be provided by the manufacturer. If any component of the supplied items becomes defective during the warranty period, the warranty shall be extended automatically (for relevant component) for the period for which the subject component remains defective.
- b. If any defect/discrepancy arises within warranty period, then the item(s) are to be replaced free of cost including freight within 03 (three) months from the date of notification of the same to the supplier. For warranty replacement, the supplier will collect the defective item(s) from NSD, Chattogram and re-supply the same to collecting place after the warranty repair.
- c. Warranty certificate is to be submitted with the offer.
- 19. <u>Guarantee</u>. Guarantee is to be given that the items will be suitable to meet the requirement mentioned in Para 2, 10 and 11. Guarantee certificate is to be submitted with the stores.
- 20. <u>Undertaking</u>. If the supplied items are found unsuitable for use by Bangladesh Navy, the same are to be taken back by the supplier without any cost to Bangladesh Navy.
- 21. <u>Final Acceptance</u>. Final acceptance of the supplied items will be given after inspection/test by the Naval Armament Inspection Organization, Chattogram (NAIO, Chattogram).

# 23. Shipment and Delivery

a. <u>Place of Delivery</u>. The supplier will arrange delivery of all the items to the following address:



- b. Items will have to be delivered within **90 days** from the date of signing of the contract.
- 24 <u>Terms of Payment</u>. Total (100%) payment will be made in local currency after satisfactory inspection and acceptance by Bangladesh Navy.
- Validity of Offer. Up to 30 June 2025.

Compliance Statement. A compliance statement mentioning all the required information is to be submitted with the offer for evaluation of tender. Any deviation from the specification is also to be mentioned in the offer. Mere mentioning of "Yes/No" or "Comply" will not be enough; detailed technical data/information of the offered item is to be provided. Incomplete compliance statement may attribute to cancellation of the offer.
