- 5. <u>Description of Defect.</u> Two in no bushing displaced from its original position (Photo attached in para-16).

- 7. Source of Repair. OEM/ OEM authorized service centre.
- 8. <u>Scope of Repair</u>. Supplier will perform the following works as per Component Maintenance Manual from OEM/ OEM authorized EASA Part 145 approved organization:
 - a. To perform repair as per component maintenance manual and technical instruction provided by Leonardo S.p.A Helicopter.
 - b. 02 (two) bushings are to be replaced with new ones, and the remaining 10 (ten) bushings are to be inspected. If any of the ten bushings are found to be defective during inspection, they are to be replaced with new ones.
 - To carryout corrosion inspection and maintain corrosion protection.
 - d. On completion of repair work, entire surface of the item is to be painted.
- 9. <u>Test, Trial and Acceptance</u>. Final acceptance will be given by CINS after satisfactory test and trial in BN Helicopter Flight Line.

10. Warranty.

- a. A warranty certificate is to be submitted for at least 12 months from the date of acceptance of the items after satisfactory test/ trial as applicable.
- b. If any defect/ discrepancy arises, within warranty period, then the respective item is to be repaired at free of cost providing ARC/ C of C including freight within 02 (two) months from the date of notification of the same to the supplier.




Fig-1: Position of 02 in no displaced bushes.
