 10. **Scope of Supply.** New and original item is to be supplied fulfilling all the criteria of tender specification.
 11. **Test, Trial and Acceptance.** Final acceptance of the item will be given after satisfactory test and trial by Naval Aviation UAV Wing.
 12. **Warranty.** At least 12 Months from final acceptance by UAV Wg.

 - d. The bidder is to provide Certificate of Warranty/ Guarantee with the item.

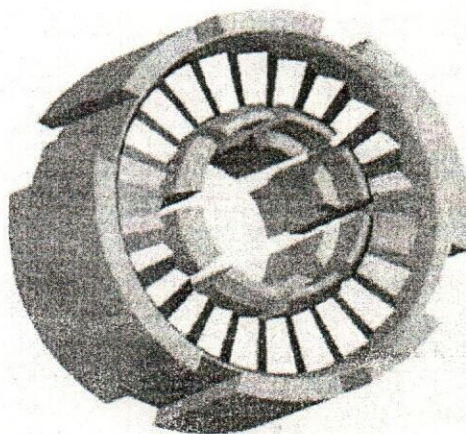
